#### I. Call to Order

Mr. Buckner called the meeting to order at 9:00 a.m. and confirmed that a quorum was present.

#### II. Approval of Prior Meeting Minutes – June 2017

Mr. Bagwell made a motion to approve the minutes, seconded by Ms. Gordon. The motion was approved unanimously.

#### III. Remarks from Mayor Habib

Mayor Habib said that he wanted to schedule a meeting with this Committee. He wants the Committee to bring value, and noted that it is an important piece of the City's strategic efforts. In the coming months, Council and Committee members will work to better define the Committee's role.

City Councilmember Jerry Tekac will be the Council liaison to the Committee.

#### IV. Update on 2017 Activity

Mr. Brady gave an overview of economic activity in the City for 2017. The City experienced record retail sales. Council also passed an incentive ordinance, and the first project involving that ordinance is underway. The year 2018 looks promising, with many major commercial construction projects underway.

### V. What's next for EDAC – Discussion

Committee members remarked that the Committee should be more involved in the City's efforts. Members want to be helpful in recruiting new business to Goose Creek, and would like to be kept apprised of new companies looking to locate. They will work to define their mission over the next several months.

Ms. Gordon remarked that it may be helpful to meet every month for approximately six months, and the Committee came to a consensus to meet the third week of the month. Mr. Brady will schedule the meetings.

Mr. Buckner stated that it would be helpful to have more data. Mr. Brady said he would bring ideas for new data to the next meeting.

## VI. Review of Sign Ordinance

The Committee had a general discussion about the sign ordinance. Generally, the Committee believes that the sign ordinance is working, but should be revisited to make sure it is practical and not harmful to businesses. No one business should dictate the City's policy initiatives, and a reasonable sign ordinance is necessary to prevent the proliferation of unattractive signs and to keep the city looking nice.

## VII. Chairman's time

Mr. Buckner reiterated the need for more detailed data. He also is looking forward to the Committee playing an active role in the economic development function of the City.

## VIII. Adjourn

Hearing no other business, Ms. Gordon made a motion to adjourn and Mr. Henderson seconded. The motion passed 6 - 0 and the committee adjourned at approximately 10:30 a.m.
