#### **Call to Order**

#### **Project Status Report**

***Athletics:*** Mr. Stuber reported baseball season began April 4<sup>th</sup>, soccer is scheduled to begin April 12<sup>th</sup> and we are accepting registration for summer basketball.

There has been vandalism to the concession stand at Felkel Field. Vandals are throwing rocks and breaking the windows. The police have been asked to increase patrols.

***Lifeguards/Pool:*** Mr. Stuber reported that we are in the process of hiring lifeguards for the pool which is scheduled to open to the public Memorial Day weekend. The Killer Waves swim team will start practice the first week in May.

Mayor Heitzler stated he had received a complaint that the pool is frequently closed to members in August and asked why. Mr. Stuber answered that we have 3 high school swim teams using the pool for practice and meets and we have to balance the times the pool is open with times the schools use the pool.

***Phase 2 Update:*** Mr. Stuber updated the Commission on this project. He is meeting with IT Director Ryan Byrd on the technology requirements for the new facility and will be visiting a gymnastics facility in Mt. Pleasant to get ideas on how to best locate certain IT equipment.

***Deeding Property to City of Goose Creek:*** This item will be discussed when a full Commission is present.

***Parks Report*** – The fields are in great condition and ready for the upcoming season.

Mayor Heitzler asked about replacing the old chain link fence at Fairfax Park. Mr. Stuber said he hadn't planned on it at this time.

Mr. Stuber stated that we are currently working on replacing the playground equipment at Shannon Park.
