All work is to be done between the hours of 8:00AM and 7:00PM, Monday thru Friday.

The contractor will be responsible for securing all necessary licenses and permits, to include, but not limited to, a City business license and Demolition Permit. All fees for licensing / permitting shall be the responsibility of the contractor. A certificate of insurance is required.

E. SUMMARY OF TASKS:

Contractor shall remove and dispose of all materials generated by the demolition activities associated with the demolition of all above ground structures and slab at 101 Old Monks Corner Rd, Goose Creek, SC 29445.

Contract work includes:

- 1. Demolition and disposal of all materials in accordance with all federal, state and local regulations.
- 2. Restoration of the site using the fill necessary to provide positive drainage. The soil used for the fill material should be capable of compaction to prevent future settling.
- 3. Upon completion of the work the contractor shall remove from the site all rubbish, debris, and trash resulting from the operation and shall remove all equipment, leaving the entire area in a safe, sanitary and acceptable condition as determined by the City
