- All banner applications are subject to review by Staff.
• Banner applications are exempt from review by the City's Architectural Review Board (ARB).
• An applicant is limited to two (2) banners during the calendar year; however, only one (1) banner may be posted at a time.
• Banners are limited to a maximum post time of thirty (30) days.
• Banners must be located on the property, (out of the right-of-way,) and are prohibited from being strung between building or utility poles. No banner shall hang from a street light, utility pole, or publicly maintained structure.
• Banners may not exceed fifty (50) square feet.

If said applicant wishes to erect a permanent sign, please contact the Department of Planning and Zoning for a Sign Permit Application. In addition, the applicant should review the City Code, Section 151.084, pertaining to sign regulations.
