#### City of Goose Creek's 2019 Christmas Parade Rules and Policies Rules and Policies:

1. Line up along Old Moncks Corner Road (from St. James Ave. to the old Casey Center lot) will begin at 9:00a.m.

*Parade starts promptly at 9:30a.m.* 2. NO CANDY, NOVELTY OR PROMOTIONAL ITEMS WILL BE THROWN TO SPECTATORS ALONG THE PARADE ROUTE FROM ANY PARADE ENTRY INCLUDING FLOATS! ALL ITEMS MUST BE UNDERHAND TOSSED OR HANDED OUT BY WALKERS.

3. \*\*At least 6 Adults must walk with unit, vehicle or float for purposes of safety and handing out items to spectators. Adult walkers must remain at the sides of the unit, close enough to spectators to keep them safely off the parade route and to hand materials directly to crowd. Adult walkers are **not** allowed to jump on and off a float or unit at any time. All children must remain on the float or in the vehicle.

4. All Walking units will be allowed to hand out candy, novelty or promotional items to spectators.

5. ALL participants in the parade must sign & submit a Christmas Parade Waiver, Release / Hold Harmless Agreement with the Christmas Parade Entry Application.

6. Participants are responsible for their own litter, at line up and along parade route, including any animal droppings.

7. Exhibitions of speed or reckless driving, (wheelies, peeling out, etc.) are **NOT PERMITTED** in the parade. All vehicles entered in the Christmas Parade must carry valid automobile insurance meeting the requirements of South Carolina law and any person driving a motorized vehicle should have a valid driver's license and must be at least (21) years of age.

8. There is only **ONE Official Santa Claus** in the parade. Impostors or Santa Clause outfits are **NOT PERMITTED** in the parade, Santa hats are acceptable.

9. It is clearly understood that the sponsoring organization will provide all personnel necessary, to man and operate the parade entry and all costumes for each of their participants.

10. Open fires, flames and fireworks are **NOT PERMITTED** in the parade by order of the Fire Marshal.

11. This is a family event and ALL parade entries must be in good taste. Parade entries will not be allowed to enter the parade route if found to be unacceptable by the Goose Creek Parade Committee.

12. Units with sound or noise *must be noted on the written application* and must maintain a set level as to not interfere with other units.

13. This is a drug/alcohol/smoke free event and will not be permitted on Goose Creek line up premises, parade route and will not be permitted at any time prior to or during the parade.

The Goose Creek Parade Committee retains the right to refuse participation of any entry that fails to comply with the above rules at any time. Failure to adhere to any of the rules or any directions made by parade officials during the event puts the parade, the Christmas Parade Committee and the community at risk. Any transgression may result in ejection from the parade and/or prohibiting the participant from participating in any future events held or sponsored by the City of Goose Creek.

#### **Special Notes:**

• The Announcers are located at the area designated for the stage in the middle of the parade route, Units may NOT STOP at any time during the course of the parade, and they should only SLOW down for review.

• Weather: The rain date for this event is scheduled for Saturday, December 21, 2019. The Parade Committee will closely monitor the weather and contact all participants/organization leaders for any possible postponement. Please plan to bring plenty of water, snacks for your group.

• Restrooms- please make sure all participants plan according. However, restrooms will be available in the field next to the old Casey Center and port-a-lets along the parade route located in the Publix parking lot.
